

INVITATION TO BID

SOUTH HILLS AREA COUNCIL OF GOVERNMENTS

Sealed proposals will be received by the South Hills Area Council of Governments (SHACOG), Allegheny County, PA until 11:00 AM on Friday, September 18, 2020 to be publicly opened and read immediately thereafter for the following project:

SHACOG 2020 Emergency Services Projects Bid Prices

The participating municipalities of the South Hills Area Council of Governments (SHACOG) find that at times they need to perform emergency construction projects or CCTV inspections/sewer cleaning to insure the proper functionality of their infrastructure. It is SHACOG's intention to receive both unit costs for typical construction items that have been included in past participant municipalities' emergency projects and prices for hourly equipment and manpower to perform miscellaneous emergency projects that are outside of the realm of those items included in the typical emergency construction projects. They also intend to receive prices for the CCTV cleaning and inspection services for emergency needs. **IT IS TO BE UNDERSTOOD THAT NO ACTUAL WORK IS BEING GUARANTEED UNDER THIS PROPOSAL.** There will not be a contract agreement awarded with this bid; however, the unit and hourly prices will be kept on file and act as a binding contract. Should the need for an emergency project arise, the participant municipality's engineer will estimate the items to be included in the project and determine which Bidder can perform the work at the lowest responsible cost to the participant municipality.

All contractors wishing to bid on this project **must** be pre-qualified by SHACOG and the participating municipalities. The required instructions will be included in the project specifications. A bid **will not** be accepted from any bidder that is not pre-qualified.

Copies of drawings, specifications, instructions to bidders, general conditions, forms of proposals and agreement may be obtained at the SHACOG office, 2600 Old Greentree Road, Carnegie, PA 15106, 412-429-1130. A non-refundable fee of \$75.00 for each set of plans will be required. An additional \$10.00 will be required for each set of plans if they are to be mailed.

Proposals must be submitted on the forms provided by SHACOG. Each proposal must be accompanied by a certified check, cashier's check or bid bond in the amount of ten (10%) percent of the bid, made payable to SHACOG. All envelopes containing bid proposals must be clearly marked: "SHACOG 2020 Emergency Services Projects Bid Prices." Proposals should be addressed to Stanley Louis Gorski, Executive Director, SHACOG, 2600 Old Greentree Road, Carnegie, PA 15106.

The proposals must be made to SHACOG, Allegheny County, Pennsylvania, and shall remain firm for a period of ninety (90) days. No bidder may withdraw his proposal during the ninety (90) day period without forfeiting his bid guarantee.

SHACOG reserves the right to reject any or all proposals, or any part thereof, for any reason, and reserves the right to waive any informality therein.
